REGIONAL GOVERNORS CHAPTER PRESIDENTS ALL CONCERNED

SUBJECT UNAUTHORIZED USE OF IIEE LOGO/SEAL

Pursuant to Republic Act 8293, also known as the "*Intellectual Property Code of the Philippines*" explicitly provides that the unauthorized use of company logo duly registered with the Intellectual Property Officer as registered Trademark is prohibited and punishable under the law.

Any person or entity with Trademark Infringement or the unauthorized use in commerce of a registered trademark or a copy or colorable imitation of the registered trademark may be charged criminally or civilly.

However, IIEE authorizes the use of its logo limited to organizational purpose/s only in order to avoid misrepresentation and maintain established goodwill.
